RE: Agreement with City of Robertsdale for Baldwin Rural Area Transportation System to Provide Assistance with Transport of Disabled Persons

Dear Mr. Jilla:

As required by the Alabama Department of Transportation and the Federal Transit Administration, enclosed is a **fully executed original** *Agreement* approved during the April 2, 2013, Baldwin County Commission meeting, between the City of Robertsdale and the Baldwin County Commission, which allows the Baldwin Rural Area Transportation System to provide assistance with transport of disabled persons that require a vehicle with a lift. This *Agreement* is for a term commencing upon full execution and ending on September 30, 2013. Unless terminated, this *Agreement* shall automatically renew for successive one-year terms on the same conditions in effect at the conclusion of the ending term. Both parties have the right to terminate this *Agreement* without cause by giving five (5) days written notice to the other party.

This Agreement ("Agreement"), dated as of April 2, 2013, is by and between the "City of Robertsdale," an Alabama municipal corporation, and the "Baldwin County Commission," the governing body of Baldwin County, Alabama, and a political subdivision of the State of Alabama.

RECITALS

WHEREAS, the City of Robertsdale has one bus that operates under Section 5310 Sub-recipients of the Alabama Department of Transportation (ALDOT) that was purchased without lift equipment; and

WHEREAS, the Baldwin County Commission has a fleet of buses that have lift equipment to accommodate persons with disabilities in Baldwin County; and

WHEREAS, the City of Robertsdale and the Baldwin County Commission seek to work together if there is a request for the City of Robertsdale to transport a person or persons with the need of a lift.

NOW, THEREFORE, in consideration of the foregoing recitals and the mutual covenants contained herein, the parties hereto agree as follows:

AGREEMENT

Purpose:

The City of Robertsdale and the Baldwin County Commission desire to establish a cooperative relationship between the City of Robertsdale and the Baldwin County Commission in the event that a bus with a lift is needed.

Responsibilities of City of Robertsdale:

The City of Robertsdale provides transportation to seniors and persons with disabilities, without prejudice.

Responsibilities of Baldwin County Commission:

The Baldwin County Commission agrees to assist the City of Robertsdale should the need arise to provide a bus with a lift for disabled persons. This assistance will require 24 to 48 hour notice for single passenger transport on established demand response routes with passengers paying standard transport fare rates.

Terms of Agreement:

This Agreement is for a term commencing upon full execution and ending on September 30, 2013. Unless terminated, this Agreement shall automatically renew for successive one-year terms on the same conditions in effect at the conclusion of the ending term.

Termination:

Notwithstanding any other provision of this Agreement, either party to this Agreement shall have the right to terminate this Agreement, with or without cause hearing, by giving five (5) days written notice of such termination to the other party.
