MEMORANDUM OF AGREEMENT

The Baldwin County Commission (hereafter "BCC") hereby retains Adams and Reese, LLP as consultants and advisors with regard to task specific federal, state and economic development representation issues. Adams and Reese, LLP undertakes to monitor and evaluate these issues and to advise BCC on the components of an agency and legislative plan and the appropriate strategy necessary to achieve the goals of such a plan. Adams and Reese, LLP will perform such services with regard to those issues as are mutually agreed to between Adams and Reese, LLP and BCC.

It is understood that Adams and Reese, LLP may be required to register for work performed on behalf of the BCC under the Lobbying Disclosure Act of 1995, as amended (2 USC §1601 et seq.) and any subsequent laws or regulations on behalf of BCC.

In consideration of the performance of these services, BCC shall pay to Adams and Reese, LLP the sum of \$6,000.00 per month, with such payments due monthly. BCC hereby warrants that these costs will not be paid with Federal funds.

This Agreement shall become effective October 1, 2016, and shall continue in effect until September 30, 2017, or unless terminated by BCC or Adams and Reese, LLP by written notice given to the other at least thirty (30) days prior to the proposed date of termination. Any fees earned or reimbursable expenses incurred prior to the receipt of said notice of termination shall be paid by BCC.

This Agreement shall be deemed to be a contract made under the laws of the State of Alabama and for all purposes shall be construed in accordance with said laws. In the event of a dispute between the parties, they mutually consent to jurisdiction in the state court of appropriate jurisdiction in the State of Alabama.


