SYSTEM PERMISSION

Date: 11/17/2021

Parties: OPERATOR (AT&T) – AT&T Services, Inc.

OWNER - Baldwin County Commission

PREMISES (address) – 55810 Canaan Rd W. Stockton AL

- OWNER grants the OPERATOR the right to install,* own, repair, operate, remove, improve, and maintain fiber optic and/or copper cable facilities and related equipment capable of accommodating voice, data and video transmissions and/or other communications service (the “System”) at the PREMISES.
- OPERATOR shall own the System that it installs, up to the point of initial demarcation, and shall install and maintain the System at its own expense in a good and workmanlike manner.
- OWNER shall own all other property at the PREMISES, including pathways for the System.
- OWNER shall provide reasonable access to the PREMISES and power for the System.
- OWNER may terminate this System Permission upon written notice if the System is not in use and this System Permission shall automatically terminate if such non-use continues for a period of 180 days.
- This System Permission is the entire agreement between the parties respecting the matters herein and may be modified by written agreement only. This System Permission is binding upon OWNER and its successors and assigns of the PREMISES.
