BALDWIN COUNTY COMMISSION**

**AMENDING RESOLUTION #2014-126, WHICH, PURSUANT TO SECTION 45-2-244.183 OF THE CODE OF ALABAMA 1975, APPROVED THE FISCAL YEAR 2015 MASTER PLANS FOR CAPITAL OUTLAY FOR THE HISTORIC BLAKELEY AUTHORITY AND FORT MORGAN STATE HISTORIC SITE; AND AUTHORIZED DISBURSEMENTS OF RENTAL LEASE TAX PROCEEDS RELATED THERETO.**

WHEREAS, during the 2007 Regular Session of the Legislature of Alabama, the Legislature of Alabama adopted Act No. 2007-377; and

WHEREAS, during the 2010 Regular Session of the Alabama Legislature, the Legislature of Alabama adopted Act No. 2010-588, which amended a portion of Act No. 2007-377, and became effective July 1, 2010; and

WHEREAS, during the 2013 Regular Session of the Alabama Legislature, the Legislature of Alabama adopted Act No. 2013-243, which amended a portion of Act No. 2010-588, and became effective May 15, 2013; and

WHEREAS, Act No. 2007-377, as last amended by Act No. 2013-243, is presently codified at Section 45-2-244.180 through Section 45-2-244.187 of the Code of Alabama 1975; and

WHEREAS, Section 45-2-244.180 through Section 45-2-244.187 of the Code of Alabama 1975 provides authority for the levy and imposition on lessors or renters of tangible personal property and any automotive vehicle or truck trailer, semi-trailer, or manufactured home in Baldwin County, Alabama, an additional license or privilege tax based on the gross proceeds of such business of leasing or renting tangible personal property and any automotive vehicle or truck trailer, semi-trailer, or manufactured home to be deposited, disbursed, and used in conformance with said Alabama law; and

WHEREAS, during the September 4, 2007, regular meeting of the Baldwin County Commission, this honorable county governing body adopted Resolution #2007-169 of the Baldwin County Commission which, among other things, implemented the levy of the applicable rental lease tax in conformance with Section 45-2-244.180 through Section 45-2-244.187 of the Code of Alabama 1975; and

WHEREAS, pursuant to the authority as set forth by Section 45-2-244.183 of the Code of Alabama 1975, during the September 18, 2014, regular meeting of the Baldwin County Commission, this honorable governing body adopted Resolution #2014-126 of the Baldwin County Commission which approved the Fiscal Year 2015 Master Plans for Capital Outlay for, and as submitted by, the Historic Blakely Authority and the Fort Morgan State Historic Site, as attached hereto as **Exhibit A** and **Exhibit B**; and

WHEREAS, with the aforementioned approval, disbursements for Fiscal Year 2015 to the Historic Blakeley Authority and Alabama Historical Commission (as owner of the Fort Morgan State Historic Site), in conformance with Section 45-2-244.183 of the Code of Alabama 1975 shall be paid quarterly by the Baldwin County Commission to said aforementioned receiving entities; and

WHEREAS, the Alabama Historical Commission, on December 18, 2015, submitted a request to the Baldwin County Commission, as attached hereto as **Exhibit C**, to include in its Fiscal Year 2015 Capital Improvement Plan for the Fort Morgan State Historic Site, the repair of the roof of the Museum at Fort Morgan and the enlargement of the sanitary septic tank system at the Fort Morgan State Historic Site; now therefore

BE IT RESOLVED BY THE BALDWIN COUNTY COMMISSION, IN REGULAR SESSION ASSEMBLED, that we hereby approve the inclusion of the repair of the roof of the Museum at Fort Morgan and the enlargement of the sanitary septic tank system at the Fort Morgan State Historic Site as described in **Exhibit C** attached, in the Fiscal Year 2015 Capital Improvement Plan of the Fort Morgan State Historic Site, as requested by the Alabama Historical Commission.




**RE: Fort Morgan State Historic Site Capital Improvement Plan Projects**

Dear Chairman Dorsey:

We wish to thank the Baldwin County Commission for the collection and disbursement of the rental lease tax proceeds in support of the Fort Morgan State Historic Site. On December 16, 2014, the Baldwin County Commission was presented with the Capital Improvement Plan for Fort Morgan State Historic Site pursuant to Section 45-2-244.183 of the Code of Alabama (1975).

The Alabama Historical Commission wishes to include the following two projects in its Capital Improvement Plan: 1) the repair of the museum's roof and 2) the enlargement of the sanitary septic tank system at Fort Morgan. We estimate the roof repair to cost approximately \$143,880.00, and the septic system to cost approximately \$27,307.50. We respectfully ask that this request be approved by the Baldwin County Commission.
