Ward and Charles Wade Waldrop, whose names are to the Grand Jury otherwise unknown, did, on or about the 27th day of May, 1955, in Baldwin County, Alabama, transport whiskey in quantities of more than five gallons, contrary to law, and

against the peace and dignity of the State of Alabama.


