

# BALDWIN COUNTY STEPPING UP INITIATIVE COMMITTEE

## General Information:

The Committee was created by the Baldwin County Commission (BCC) on June 4, 2019 (Agenda Item BA3), at the recommendation of the Baldwin County Sheriff. The purpose of the Committee is to review data and provide recommendations to the Sheriff and BCC in an effort to reduce the number of people with mental illnesses in the BC Corrections Center and the municipal jails in Baldwin County.

## Composition of Planning Team:

Stepping Up Project Coordinator – Baldwin County Sheriff (or designee of the Sheriff)

Representative planning team should comprise of key leaders from the criminal justice and behavioral health systems, people who have mental illnesses, advocates, and representatives from county, municipal, and state government. These leaders may include sheriffs, police chiefs, jail administrators, judges, prosecutors, defense attorneys, community supervision officials, directors of county health and behavioral health departments, community-based behavioral health care providers, health care financing experts, private citizens, organizations that represent people who have mental illnesses and their families, representatives from housing and other human and social service agencies, mayors, and county commissioners, supervisors, or managers. The planning team might be part of an existing criminal justice coordinating council or task force.
