

## BALDWIN COUNTY PERSONNEL APPEALS BOARD

Board is composed of five (5) members

Two (2) members are appointed by Baldwin County Commission, two (2) members are elected by county classified employees & one (1) member selected by other four (4) members

All members must be residents of Baldwin County

No member shall hold elective office or be a candidate for elected office or receive a salary from the county (except the county classified employee board members) shall serve on the board

Term of members is three (3) years

Compensation of Board Members: Chairman, \$100 per meeting attended; other Board Members, \$75 per meeting attended
