## General Board Information:

Appointed by Baldwin County Commission. Nine (9) members, term of each member is six (6) years. All members must reside in Baldwin County.

Originally incorporated as "North Baldwin County Hospital Corporation" and reincorporated as "North Baldwin County Health Care Authority" in 1991. Statutory Authority §22-21-310 and §22-21-352 et seq., Code of Alabama 1975.

In the event of a vacancy resulting from the expiration of a term, the board shall, not more than 90 nor less than 10 days prior to the expiration of such term of office (or in case of a vacancy resulting from the death or resignation of any such director or from a cause other than the expiration of the stated term of office of any such director, within 30 days following the occurrence of such vacancy), nominate three (3) names for each place seat by Resolution of the Authority which is certified and forwarded to County Commission. County Commission shall choose one (1) name, of the three (3) names, for each vacancy. Notwithstanding the aforementioned, the County Commission reserves any authority granted by Alabama law.
