SUPPLIES

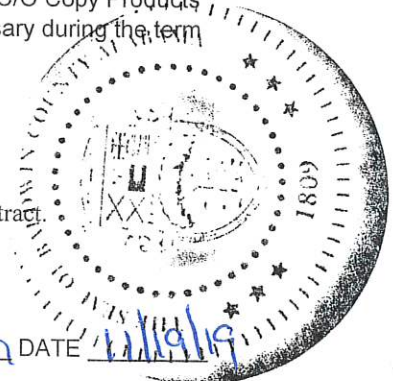
