AGREEMENT

This Agreement is made and entered into by and between the County of Baldwin (hereinafter "COUNTY") acting by and through its governing body, the Baldwin County Commission, and the Little River Volunteer Fire Department (s), Inc., a domestic nonprofit corporation listed in the Office of Secretary of State of the State of Alabama under Business Entity Number 023-838 (hereinafter "LITTLE RIVER VFD").

WITNESSETH:

WHEREAS, the COUNTY and the LITTLE RIVER VFD endeavor to work together to ensure the health, safety and welfare of the general public of the unincorporated community of Little River, Alabama; and

WHEREAS, the LITTLE RIVER VFD is a recognized volunteer fire department in Baldwin County, Alabama, certified by the Alabama Forestry Commission and eligible to receive public tax proceeds derived under Section 45-2-242 of the Code of Alabama 1975 (i.e. Baldwin County Local Act No. 90-449) which LITTLE RIVER VFD works to provide public fire and emergency rescue services to the general public of the unincorporated community of Little River, Alabama; and

WHEREAS, the COUNTY understands that the LITTLE RIVER VFD will play an important role in protecting the health, safety and welfare of the general public and, desiring to work with the LITTLE RIVER VFD toward the aforesaid endeavor, seeks to enter into this Agreement to aid the LITTLE RIVER VFD with "in-kind services," as set forth herein, to promote the public good of the unincorporated community of Little River, Alabama; and

WHEREAS, the parties now wish to set out their arrangement in this written Agreement.

NOW, THEREFORE, in consideration of the premises and the mutual covenants herein contained the sufficiency of which being hereby acknowledged, the LITTLE RIVER VFD and COUNTY do hereby agree as follows:

- I. Recitals Included. The above recitals and statements are incorporated as part of this Agreement, and shall have the effect and enforceability as all other provisions herein.
- II. <u>Definitions.</u> The following terms shall have the following meanings:

i. COUNTY:

Baldwin County, Alabama

ii. COMMISSION:

Baldwin County Commission

iii. LITTLE RIVER VFD:

Little River Volunteer Fire

Department (s), Inc.

III. No Prohibited Exclusive Franchise. The COUNTY neither perceives nor intends, by this Agreement, a granting of an exclusive franchise or violation of Art. I, Section 22 of the Alabama Constitution.

- IV. <u>Legal Compliance</u>. The LITTLE RIVER VFD shall at all times comply with all applicable Federal, State, local and municipal laws and regulations.
- V. <u>Independent Contractor</u>. The LITTLE RIVER VFD acknowledges that it is an independent contractor, and that the LITTLE RIVER VFD shall at all times remain as such in performing the services under this Agreement. The LITTLE RIVER VFD is not an employee, servant, partner, or agent of the COUNTY and has no authority, whether express or implied, to contract for or bind the COUNTY in any manner.
- VI. No Agency Created. It is neither the express nor the implied intent of the LITTLE RIVER VFD or COUNTY to create an agency relationship pursuant to this Agreement; therefore, the LITTLE RIVER VFD does not in any manner act on behalf of COUNTY and the creation of such a relationship is prohibited and void.
- VII. <u>Unenforceable Provisions</u>. If any one or more of the provisions contained herein shall, for any reason, be held to be invalid, illegal or unenforceable in any respect, then such provision or provisions shall be deemed severable from the remaining provisions hereof, and such invalidity, illegality or unenforceability shall not affect any other provision hereof. This Agreement shall be construed as if such invalid, illegal or unenforceable provision had never been contained herein.
- VIII. Entire Agreement. This Agreement represents the entire and integrated agreement between COUNTY and the LITTLE RIVER VFD and supersedes all prior negotiations, representations, or agreements, either written or oral. This agreement may be amended only by written instrument signed by all parties.
- IX. Failure to Strictly Enforce Performance. The failure of the COUNTY to insist upon the strict performance of any of the terms, covenants, agreements and conditions of this Agreement shall not constitute, and shall never be asserted by the LITTLE RIVER VFD as constituting, a default or be construed as a waiver or relinquishment of the right of the COUNTY to thereafter enforce any such term, covenant, agreement, or condition, but the same shall continue in full force and effect.

- X. <u>Assignment</u>. This Agreement or any interest herein shall not be assigned transferred or otherwise encumbered by the LITTLE RIVER VFD without the prior written consent of the COUNTY, which may be withheld or granted in the sole discretion of the COUNTY.
- XI. <u>Notice</u>. Notice required herein shall be in writing, unless otherwise allowed, and said notice shall be deemed effective when received at the following addresses:

XII. General Responsibilities of the LITTLE RIVER VFD.

- (1) The LITTLE RIVER VFD expressly agrees to allow the utilization of enough of its property, as described and depicted in **Exhibit A** hereto, to accommodate the construction and use of a helicopter landing pad for emergency response use of the general public, said provision benefiting the health, safety and welfare of the general public.
- (2) The LITTLE RIVER VFD expressly agrees to allow the utilization of its LITTLE RIVER VFD fire station's internal premises as located on its property, as described and depicted in **Exhibit A** hereto, to be utilized for voting and, correspondingly, the LITTLE RIVER VFD expressly agrees to allow said LITTLE RIVER VFD fire station to be designated as a Voting Place by the COUNTY and for the Baldwin County Voting Precinct comprising the unincorporated community of Little River, Alabama, said provision benefiting the exercise of the electoral franchise for the registered voters in the Voting Precinct comprising the unincorporated community of Little River, Alabama.


XIII. General Responsibilities of the COUNTY.

(1) The COUNTY shall provide "in-kind" services to the LITTLE RIVER VFD including, but not limited to, land clearing services and the construction of a helicopter landing pad on the property of the LITTLE RIVER VFD, as depicted in **Exhibit A** hereto, and as determined necessary by the COUNTY Engineer, said provision of "in-kind" services benefiting the health, safety and welfare of the general public by allowing the use of said property by the LITTLE RIVER VFD for the provision of public fire and emergency rescue services to the unincorporated community of Little River, Alabama.

XIV. <u>Termination of Services</u>. The COUNTY may terminate this Agreement, with or without cause or reason, by giving thirty (30) days written notice of such to the LITTLE RIVER VFD. The LITTLE RIVER VFD expressly agrees that this Agreement binds said LITTLE RIVER VFD to the term of this Agreement for a twenty (20) year period during which period the LITTLE RIVER VFD shall in no way be allowed by the COUNTY to be relieved of the parameters set forth at Section XII (1) and (2) as set forth herein.

- XV. Effective and Termination Dates. This Agreement shall be effective and commence on September 4, 2012, and the same shall terminate on September 4, 2032, or upon a written notification of termination issued by the COUNTY as set forth herein.
- XVI. Force Majeure. The Parties hereto shall incur no liability to the other if performance becomes impossible or impracticable by reason on an event or effect that the parties could neither have anticipated nor controlled. This allowance shall include both an act of nature and acts of third parties. Any costs that would otherwise be incurred and/or necessitated by the provisions herein shall be alleviated for either party by such event or effect.
- XVII. Indemnification. The LITTLE RIVER VFD shall indemnify, defend and hold COUNTY and its Commissioners, appointed contract employees, directors, affiliates, employees, agents, representatives, contractors, subcontractors, licensees and invitees (collectively herein, "COUNTY") harmless from and against any and all claims, demands, liabilities, damages, losses, judgments, costs, and expenses including, without limitation, attorneys' fees, for any and all personal injury (including death), property damage or any other damage or injury of any kind or nature whatsoever, incurred by, asserted against, or imposed upon COUNTY, arising from or related to this Agreement or the services to be provided hereunder. The LITTLE RIVER VFD expressly agrees that this indemnification shall survive the expiration of this Agreement.
- XVIII. Governing Law. This Agreement in all respects, including without limitation its formation, validity, construction, enforceability and available remedies, shall be governed by the laws of the State of Alabama, without regard to Alabama choice of law principles.
- **XIX.** <u>Number of Originals</u>. This Agreement shall be executed with two originals, both of which are equally valid as an original.
