OF THE BALDWIN COUNTY COMMISSION**

**RESOLUTION AUTHORIZING THE ACCEPTANCE OF TWO MINIVANS FROM THE  
ESCAMBIA COUNTY BOARD OF COUNTY COMMISSIONERS AND ASSUME THE  
FTA INTEREST**

**WHEREAS**, the Baldwin County Commission requires two (2) wheel-chair accessible minivans to maintain a reliable fleet for its public transit service; and

**WHEREAS**, the Escambia County Board of Commissioners allocated funding in its FL-2020-052 and FL-2022-007 grant awards to purchase two (2) transit vehicles to support Baldwin County Commission's public transit service within their UZA; and

**WHEREAS**, the Baldwin County Commission will assume the FTA interest in the vehicles in the amount of \$132,407.00; and

**WHEREAS**, the Baldwin County Commission will maintain these vehicles in accordance and compliance with FTA requirements; and

**WHEREAS**, the Baldwin County Commission will include these transferred vehicles on its equipment inventory records.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION AS FOLLOWS:**

- 1) The above stated recitals are true and correct and incorporated by reference herein.
- 2) The Baldwin County Commission hereby authorizes the acceptance of the two (2) minivans, as identified in Exhibit A, from the Escambia County Board of Commissioners and assume the FTA interest in the amount of \$132,407.00.
- 3) The Baldwin County Commission hereby authorizes the Chairman to sign this Resolution.
- 4) This Resolution shall take effect immediately upon adoption by the Baldwin County Commission.

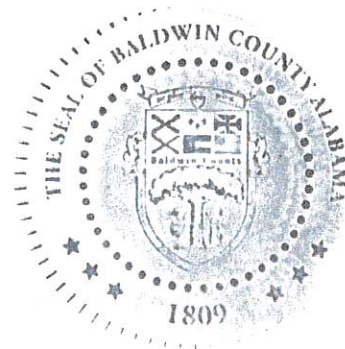
