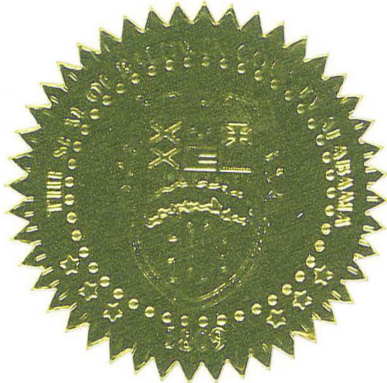
WHEREAS, with Mrs. Biles' many accomplishments and over 40 years of public service; and


WHEREAS, Mrs. Biles will enjoy time spent with family and grandchildren, travel a bit, and do some volunteer work; now therefore







