DETERMINATION OF THE BALDWIN COUNTY COMMISSION, REGARDING **CASE No. Z24-53, Gatlin Property** SUCH DETERMINATION AS AUTHORIZED PURSUANT TO SECTION 45-2-261 THROUGH SECTION 45-2-261.18, CODE OF ALABAMA (1975).

**WHEREAS**, Baldwin County Planning and Zoning Department has petitioned the Baldwin County Commission, on behalf of David Gatlin to rezone certain property, in Planning (Zoning) District No. 30, for property identified herein and described as follows:

Otherwise known as tax parcel numbers, **05-61-07-26-0-000-007.000** and **05-61-07-26-0-000-007.001** as found in the office of the Revenue Commissioner of Baldwin County, Alabama; and

**WHEREAS**, the petitioner has requested that 40+/- acres be rezoned from RA, Rural Agricultural District, to RSF-2, Residential Single Family District and



**WHEREAS**, the Baldwin County Commission held a public hearing on February 18, 2025; and

**BE IT RESOLVED, BY THE BALDWIN COUNTY COMMISSION, IN REGULAR SESSION ASSEMBLED**, That the petitioner's request to rezone 40+/- acres (Case No. Z24-53, Gatlin Property) as herein identified and described and as found within the confines of Planning (Zoning) District No. 30 from RA, Rural Agricultural District, to RSF-2, Residential Single Family District, which amends the Planning (Zoning) District Boundary designations of the Planning (Zoning) District No. 30 Official Map, is hereby **APPROVED**.
