WHEREAS, the Baldwin County Commission participates in the National Flood Insurance Program and the Community Rating System (CRS); and

WHEREAS, on April 2, 1996, the Baldwin County Commission adopted Resolution #96-25 adopting the Floodplain Management Plan for Baldwin County unincorporated areas; and

WHEREAS, on December 19, 2000, the Baldwin County Commission adopted Resolution #2001-11 which approved an updated Floodplain Management Plan for the unincorporated areas of Baldwin County, and which plan is still in effect today; and

WHEREAS, the Floodplain Management Plan is a requirement for participation in the CRS for all "Category C" repetitive loss communities including Baldwin County; and

WHEREAS, Baldwin County presently enjoys a CRS classification of 7 which provides for a 15% discount on flood insurance premiums for many residents of unincorporated Baldwin County; and

WHEREAS, the Floodplain Management Plan must be updated to meet the current 1999 CRS planning criteria in order to maintain the CRS classification of 7; and

WHEREAS, in order to update the current Floodplain Management Plan, the Baldwin County Commission desires to establish a temporary Floodplain Management Planning Committee to assist the Baldwin County Emergency Management Agency (EMA), Building Inspections Department, and Amec Foster Wheeler Environmental & Infrastructure, Inc., which company was contracted on December 5, 2017, to provide consulting services related to the Floodplain Management Plan for Baldwin County; and

NOW, THEREFORE BE IT RESOLVED, that the Baldwin County Commission hereby approves the establishment of a temporary Floodplain Management Planning Committee to form on April 3, 2018, and reconvene quarterly upon the completion of the updated Floodplain Management Plan to ensure implementation of this plan and to receive maximum credit under CRS planning Step 10, on or before December 16, 2018, whichever comes first; and

**BE IT FURTHER RESOLVED**, that the Committee and that the respective staff members and officials identified to perform certain activities are hereby directed to implement
