WHEREAS, Corporal Garner served on the Emergency Response Team and as a Field Training Officer, and

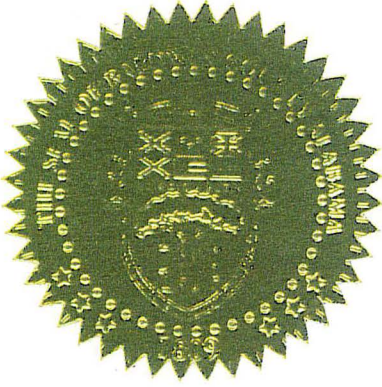
