The Plaintiff, as the assignee of Mobile Appliance Mart, for a valuable consideration, claims of the Defendant, FOUR HUNDRED SEVENTY SIX AND 95/100 Dollars (\$476.95) for merchandise, goods and chattels sold by the Plaintiff's assignor to the Defendant, under conditional sales contract dated, on to-wit, April 18, 1963, wherein the Plaintiff's assignor sold to the Defendant, to-wit, One (1) Gibson Air Conditioner, for the purchase price of Four Hundred Seventy-six and 95/100 Dollars (\$476.95). Plaintiff avers that the said merchandise was delivered to the Defendant and that no monies were paid to the Plaintiff, thereby remains a balance due and unpaid under said contract of Four Hundred Seventy-six and 95/100 Dollars (\$476.95), together with interest thereon at the rate of eight per cent (8%) per annum.

The Plaintiff alleges that the Defendant agreed in writing, as contained in said conditional sales contract, to waive all his rights and claims to personal property as exempted to him under the laws of this State or any other State and Plaintiff further claims a reasonable attorney's fee and all costs of collection, as provided for in said contract.
