Def. admitted possession but claimed it was given to him by another party. He had party whom he claimed gave him meat in Court to testify he gave def. meat.

The Court found def. guilty and a fine of \$50 plus cost was imposed. Def. appealed Court referring trial by jury.

Bond set \$900.

Def. posted bond.

The Court had office Walter put evidence in cold storage to be held for hearing.
