

TO Bay Slacks, Inc. — Greeting:

Whereas, at the Fall Term, 1962, of the Baldwin County Court of Baldwin County, Alabama, James E. Byrd, Plaintiff, recovered a judgment against Mamie Lee Byrd and cost of suit; and

Whereas, on, to-wit, November, 1962, an Order of Execution was duly issued in and by said Court, in said cause, which said Execution has been duly placed in my hands, as Sheriff of Baldwin County, Alabama; and

Whereas, under and by virtue of the aforesaid Execution I, as Sheriff of Baldwin County, Alabama, have been commanded to seize and levy upon the estate, goods, earning, and property of said ~~Defendant~~ <sup>Plaintiff</sup> in order to obtain payment and satisfaction of the aforesaid judgment for damages and costs of suit.

THESE PRESENT ARE THEREFORE TO COMMAND YOU, that you be and appear before the Baldwin County Court of Baldwin County, Alabama, within fifteen days from the service of this Writ of Garnishment, then and to answer, on oath, as Garnishee, whether, at the time of service of this writ of Garnishment, or at the time of making your answer, or at any time intervening between the time of service of this Writ of Garnishment and the making of your answer, you are or were indebted to said ~~Defendant~~ <sup>Plaintiff</sup>; and whether by a contract now or then existing you will be indebted to said ~~Defendant~~ <sup>Plaintiff</sup> in the future; and whether by a contract now or then existing, you are or will be liable to said ~~Defendant~~ <sup>Plaintiff</sup> for the delivery of personal property or for the payment of money which may be discharged by the delivery of personal property; and whether you have in your possession or under your control money or effects belonging to said ~~Defendant~~ <sup>Plaintiff</sup>. And this you shall in nowise omit.

The Judgment in said cause was \$                    ; the Cost of Court in the original suit was \$16.00 and the Court Cost of this Garnishment proceeding is \$1.50; making a total of \$17.50 to be collected from said ~~Defendant~~ <sup>Plaintiff</sup>

If your answer shows an indebtedness due or to become due by you to said ~~Defendant~~ <sup>Plaintiff</sup> for wages, salaries, or other compensation of laborers or employees for personal service, then you are commanded to retain 25% thereof during such period of time as is necessary to accumulate a sum equal to \$17.50, at which time you will pay said sum to me, as Sheriff of Baldwin County, Alabama.

Should the employment of said ~~Defendant~~ <sup>Plaintiff</sup> be terminated, you will report such termination to me within fifteen days after the termination, and pay to me, as Sheriff of Baldwin County, Alabama, all sums which you have been commanded by this Writ of Garnishment to withhold from the ~~Defendant's~~ <sup>Plaintiff's</sup> wages, salaries, or other compensation.
