In and by the terms of said note, the Plaintiff hereof had the option to declare the whole balance of said note due on any default by said Defendants.

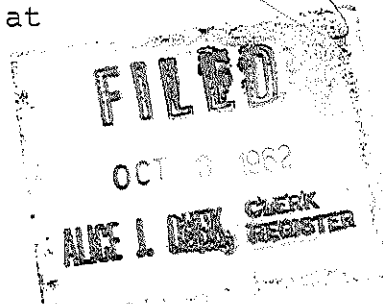
