TO THE HONORABLE F.W. HARE, JUDGE IN THE CIRCUIT COURT
OF BALDWIN COUNTY, ALABAMA, SITTING IN EQUITY.

Your Oratrix, Amy Cloud Rockwell, shows unto your Honor that she is a resident of the County of Mobile, State of Alabama and that she is over the age of twenty-one years; that Owen Lorenzo Rockwell, the respondent is a resident of Baldwin County, State of Alabama and is over the age of twenty-one years and thereupon your oratrix complains and shows unto the Court and your Honor as follows:

1. Your Oratrix shows unto your Honor that Oratrix has been a bona fide resident of this state for one year next preceding the filing of this bill.

2. That Oratrix and Respondent inter-married on or about March 12, 1932 in the City of Fairhope, County of Baldwin, State of Alabama and ever since have been and now are husband and wife.

3. Your Oratrix shows unto your Honor that there are three children namely: Sarah Otelia Rockwell, born March 29, 1934 now six and one-half years old; Wilma Ann Rockwell, born on or about October 3, 1936 now about four years old; and Margaret Cecile Rockwell, born on or about May 26, 1938, now two years and four months, born to Oratrix and Respondent.

4. That on diverse occasions between the dates of September 1939 and August 29, 1940 Respondent has conducted himself towards Oratrix in such a manner as to cause her to be apprehensive of violence attended with danger to her life, her limb and her health. That on or about September, 1939 Respondent bruised Oratrix' arms and wrists; on or about December 24, 1939 Respondent held Oratrix' wrists and refused to allow Oratrix to leave the house. A struggle ensued in which Oratrix was injured. On or about January 28, 1940 Respondent struck Oratrix on back and sides. On or about

February 28, 1940 Respondent struck Oratrix on the mouth causing her mouth to bleed and also bruised Oratrix wrists and arms. On or about August 29, 1940 your Respondent attempted to choke Oratrix and waved a hammer at her head and threatened to beat her to death and the Respondent has been guilty to extreme and repeated cruelty to your Oratrix. During all this time there were numerous occasions when threats were made.

PRAYER FOR PROCESS

Your Oratrix also prays your Honor to grant to her all appropriate and legal process and that the same be directed to the said Owen Lorenzo Rockwell, Respondent, commanding him to personally appear before the Honorable Court within the time required by law, and to then and there answer fully and completely the several paragraphs of this Bill of Complaint, and that he be required to abide and obey all orders and decrees of this Court, which to your Honor may seem meet and proper.

PRAYER FOR RELIEF

Your Oratrix prays that she be granted a judicial separation from bed and board between herself and Respondent.

That she be awarded the custody and care of her three children.

That Respondent be required to provide a reasonable sum for the support of your Oratrix and for the support of her three children.

Your Oratrix further prays that Respondent may be required to pay a reasonable sum to the Court to defray the expenses of this action and the counsel fees.

Yours Oratrix prays for such other further and general relief that she may be entitled to in equity and good conscience.
