- 6. For aught that appears the Plaintiff does not set out where he attempted to obtain any credit or where he was refused any credit.
- 7. For aught that appears Plaintiff does not set out who caused him great physical and mental pain and suffering.
- 8. For aught that appears Plaintiff does not set forth any expenses or purposes for which said expenses were incurred, or that expenses were incurred as a result of any acts of the Defendant.
- 9. For aught that appears Plaintiff fails to show what person, if any, forged checks or presented same to the Defendant for payment.
- 10. For aught that appears Plaintiff fails to show in what way his social standing has suffered.
- 11. For aught that appears Plaintiff fails to show how his business reputation for honesty and integrity was impaired by virtue of Defendant's wantonly failing to make available to Plaintiff after demand, monies which he had in checking account with Defendant.

- 12. No facts are alleged on which the release sought can be granted.
- 13. It is avague, sindefinite and uncertain in that it does not allege with sufficient certainty when the Defendant converted property or money belonging to the Plaintiff.
