COUNT I

The Plaintiff claims of the Defendant FOUR HUNDRED SEVENTY-EIGHT AND NO/100 (\$478.00) DOLLARS due by promissory note made by him on, to-wit, the 10th day of December, 1959, and payable in monthly installments of FIFTY DOLLARS (\$50.00) each, first payment to be made on the 31st day of December, 1959, and a like amount due on the same day every month thereafter until the full amount has been paid, with the interest thereon.

And the Plaintiff avers that in said note and as part of the consideration thereof, the Defendant agreed to pay an attorney's fee for the collection thereof and the Plaintiff hereby claims the further sum of ONE HUNDRED AND NO/100 (\$100.00) Dollars as such attorneys' fee.

COUNT II.

The Plaintiff claims of the Defendant the sum of EIGHTY-THREE AND NO/100 (\$83.00) DOLLARS due by promissory note made by him on, to-wit, the 22nd day of October, 1959, and payable in twelve monthly installments of TEN AND NO/100 (\$10.00) Dollars each, first payment of which is payable on the 30th day of November, 1959, and a like amount every month until the full amount has been paid, with the interest thereon.

And the Plaintiff avers that in said note and as part of the consideration thereof, the Defendant agreed to pay an attorney's fee for the collection thereof and the Plaintiff hereby claims the further sum of TWENTY-FIVE AND NO/100 (\$25.00) Dollars as such attorney's fee.
