Chemical structures of the monomers used in the synthesis of polyimides.

The figure shows four chemical structures labeled A, B, C, and D. Structure A is 4,4'-oxydianiline, consisting of two benzene rings connected by an oxygen atom at the para positions, with amino groups (-NH₂) at the other para positions.
