That said appellant has permitted its workable program under which these eminent domain proceedings were instituted expire on July 1, 1963.

That the said plaintiff has failed to comply with the requirements of the Housing and Home Finance Agency in that a comprehensive committee plan has not been prepared and filed under which sound community developments in the future will be carried out.

The said plaintiff has failed to comply with the regulations of the Housing and Home Finance Agency in that housing resources have not been specified to meet the needs for housing displaced families under a community wide re-location program.

That said plaintiff has failed to comply with the regulations of the Housing and Home Finance Agency in that citizen participation

has not been provided as a part of the workable program in that a special committee on minority group housing, on which committee, minority groups are represented has not been established.

That the said plaintiff is dependent on its funds for the approval of the Housing and Home Finance Agency, which requires that to obtain these funds, the said project must be certified and such certification required the enactments of codes and ordinances in the community, meeting the approval of the U.S. Housing and Home Finance Agency, the preparation and establishing of a comprehensive committee plan under the approval of the Federal Housing and Home Finance Agency, establishment of an administrative eganization or revision of existing local government departments with the possible increase in the tax base of the community, citizen participation is required and minority group participation is required on the citizen committees.

That the said program of the Bay Minette Housing Authority has lapsed and therefore, the plaintiff being ineligible for Federal aid, is without funds to continue the condemnation; hence this motion for dismissal.
