That said appellant has permitted its workable program under which these eminent domain proceedings were instituted expire on July 1, 1963.

That the said plaintiff has failed to comply with the requirements of the Housing and Home Finance Agency in that a comprehensive committee plan has not been prepared and filed under which sound community developments in the future will be carried out.

The said plaintiff has failed to comply with the regulations of the Housing and Home Finance Agency in that housing resources have not been specified to meet the needs for housing displaced families under a community wide re-location program.

-6-

The said plaintiff has failed to comply with the regulations of the Housing and Home Finance Agency in that citizen participation has not been provided as a part of the workable program in that a special committee on minority group housing, on which committee,

minority groups are represented has not been established.

-7-

That the said plaintiff is dependent on its funds for the approval of the Housing and Home Finance Agency, which requires that to obtain these funds, the said project must be certified and such certification requires the enactments of codes and ordinances in the community meeting the approval of the U.S. Housing and Home Finance Agency, the preparation and establishing of a comprehensive committee plan under the approval of the Federal Housing and Home Finance Agency, establishement of an administrative organization or revision of existing local government departments with the possible increase in the tax base of the community, citizen participation is required and minority group participation is required on the citizen committees.

That the said program of the Bay Minette Housing Authority has lapsed and therefore, the plaintiff being ineligible for Federal aid, is without funds to continue the condemnation; hence this motion for dismissal.

-9-

That said bond does not meet the requirements of the law if approved, in that the mortgages against the property of said bonds-man far exceed the assessed valuation of said properties.

-10-

That said condemnation proceedings is based on a program requiring an increase in taxation in the community.

-11-

That the operation of said Housing Authority is dependent on the community complying with all necessary rules and regulations of a federal agency.

-12-

That the said alleged bond is invalid in that the homestead property of the said bondsman in the name of the said bondsman and his wife is assessed in the total amount of \$7,000.00 whereas the mortgages of record against said property in Mortgage Book 244, pages 13-16 is in the amount of \$9,900.00, said recordings being in the office of the Judge of Probate of Baldwin County.

Wherefore, said bonds are nullities; hence this motion.

That appellant is an alleged corporation without assets or funds and has no money to pay the costs or damages to the appellees, landowners, the title to whose property is clouded by lis pendens filed by appellant against said property.

A RESOLUTION DECLARING THE NEED FOR A HOUSING AUTHORITY TO FUNCTION IN THE CITY OF BAY MINETTE ,ALABAMA

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF Bay Minette ALABAMA:

That a petition having been filed with the City Glerk of said City by twenty-five (25) residents thereof, and an area within 10 miles from the territorial boundaries thereof, setting forth that there is a need for a Housing Authority to function therein, and a public hearing having been held, upon due notice given by said City Clerk, all pursuant to the "Housing Authorities Law" of the State of Alabama, as amended, the City Council of said City Finds, determines and declares, that:

- l. Insanitary and unsafe inhabited dwelling accommodations exist in the City of Bay Minette, Alabama and the area within 10 miles from its territorial boundaries; and
- 2. There is a lack of safe and sanitary dwelling accommodations in the City of <u>Bay Minette</u>, Alabama and the area within 10 miles from its territorial boundaries; and
- 3. There is need for a Housing Authority to function in the City of Bay Minette, Alabama and the area within 10 miles from its territorial boundaries; and
- 4. A petition setting forth the need for a H^Ousing Authority to function in the City of <u>Bay Minette</u>, Alabama, and the area within 10 miles from the territorial boundaries thereof, has not been denied by the City Council thereof within three months of the date of the filling of the aforesaid petition; and
- 5. The Mayor of the City of Bay Minette, Alabama, be promptly notified of the adoption of this resolution; and
- 6. The Mayor be and he hereby is directed to file in the office of the City Clerk of the City of Bay Minette, Alabama, the necessary certificate evidencing the appointment of the Commissioners and designation of the first Chairman of the Housing Authority, pursuant to Section 7 of the "Housing Authorities Law" of the State of Alabama; and

Said lack of safe and sanitary dwelling accommodations in the City of Bay Minette, Alabama, and the area within 10 miles from the territorial boundaries thereof available for all the inhabitants thereof, at rents which persons of low income can afford, compels such persons to occupy overcrowded and congested dwelling accommodations; that the aforesaid conditions cause and increase in and spread of disease and crime; that the clearance and reconstruction of the areas in which insanitary or unsafe housing conditions exist for public uses and purposes, and that it is in the public interest that work on such projects be instituted as soon as possible in order to relieve unemployment which now constitutes an emergency; that it is necessary to the immediate preservation of the public peace, health and safety that this resolution become effective without delay, and, therefore, the same shall take effect and be in force immediately upon its adoption.
- 8. This resolution shall be transmitted within forty-eight hours to the Mayor for his approval, who, if he shall approve thereof, shall sign and return same to the clerk, who shall cause it to be published.
