

Ard, was riding as a passenger in a motor vehicle proceeding eastwardly on U. S. Highway 98 at a point four-fifths of a mile east of its intersection with Baldwin County Road #27, both public highways, in Baldwin County, Alabama, whereupon at the said point, the Defendant, Albert W. Bergman, III, so negligently operated a motor vehicle westwardly on U. S. Highway 98 so as to cause or allow said vehicle to collide with the said motor vehicle in which Plaintiff's intestate was riding as a passenger, and as a direct and proximate result of the negligence of the said Defendant, the said Della H. Ard suffered fatal injuries from which and as a proximate result of which she died on, to-wit: January 12, 1963, to the Plaintiff's damage, as aforesaid, hence this suit.


