

The Plaintiff claims of the Defendants the sum of One Thousand Dollars (\$1,000.00) as damages for that on, to-wit: February 1, 1963, Daniel Wayne Voiles was riding as a passenger in an automobile owned by the Defendant Louis Reed and driven by the Defendant Danny Reed, which said automobile was being driven on U. S. Highway 98 in Montrose, Baldwin County, Alabama, and at said time and place, the Defendant Louis Reed, acting by and through the Defendant Danny Reed, who was then and there the agent, servant or employee of the Defendant Louis Reed, and acting within the

line and scope of his employment as such, so negligently operated such motor vehicle as to cause or allow it to collide with a motor vehicle being driven by one George Craig, and as a proximate result of the negligence of such Defendants, the said Daniel Wayne Voiles was injured in this: he received a fractured pelvis and a concussion and was caused to incur medical and hospital expenses in the care and treatment of his said injuries, all to the damage of the Plaintiff in the sum above mentioned, hence this suit.
