
The Plaintiff claims of the Defendant the sum of SIX HUNDRED SEVENTY\_SIX DOLLARS (\$676.00) as damages, for that, and heretofore on, to-wit, the 12th day of May, 1962, the Defendant entered into a written contract with Spanish Fort Auto Sales of Spanish Fort Alabama, in which said contract subsequently assigned to the Plaintiff wherein the Defendant purchased one used Buick Automobile and agreed in the said written contract to pay therefor the sum of Seven Hundred Twenty Dollars (\$720.00) in monthly installments of Forty Dollars (\$40.00) each, beginning on the 15th day of June, 1962.

That in and by the terms of the said agreement, the Defendant agreed that should he default in any one payment that the entire balance should become due and payable at the option of the holder of the said Contract, and the plaintiff avers that the defendant became in default on to-wit, the 11th day of September, 1963, and since that date has failed and refused to abide by the terms of the said agreement.

Plaintiff further avers that in and by the terms of said Contract, the Defendant promised to pay all cost of collection under the said Contract whether secured by suit or otherwise, including a reasonable attorney's fee, and the Plaintiff now claims the further and additional sums of One Hundred Thirty-five Dollars (\$135.00) as a reasonable attorneys fee.

Plaintiff further avers that in and by the terms of said Contract, the Defendant waived all exemptions under the

Laws of the State of Alabama, and the plaintiff now claims the benefit of said waiver.
