

it filed in the office of the Judge of Probate of Baldwin County, Alabama, in which county said property is situated, a statement in writing, certified by its President who has knowledge of the facts therein stated, containing a just and true account of the debts secured by said lien after all just credits had been given, a description of the property on which the lien is claimed, and the name of the owner thereof, which said instrument is of record in the office of said Judge of Probate, in Lien Book 006, pages 203--204. Wherefore Plaintiff prays that said lien may be established upon said property, and that the same may be condemned to be sold for the purpose of satisfying said demand and lien together with the interest thereon.

Plaintiff further shows that under the terms and conditions under which the sale and purchase of the material was made, the Defendant agreed to pay interest at the rate of eight per cent (8%) per annum after maturity and all attorney's fee for collection, and all personal exemptions were waived, of which the Plaintiff now claims the benefit, and claims the further and additional sum of \$74.60 as attorney's fee.
