

BILL OF COMPLAINT

The Plaintiff claims from the Defendants Three Hundred Sixty-Six and 66/100 Dollars (\$366.66) for the breach of the condition of a bond made by the Defendant and the Plaintiff as surety on the 6th day of January, 1962, payable to The State of New Mexico in the sum of Fourteen Hundred and No/100 Dollars (\$1400.00), a copy of which is attached hereto as "Exhibit A", and made a part hereof, with condition that the Defendant would promptly file true reports and make prompt payments of any and all motor vehicle fuel taxes levied or imposed by the State of New Mexico, together with any and all penalties and/or interest thereon. And the Plaintiff says the condition of the said bond has been broken by the Defendant in this.

FIRST: That the Defendant failed and refused to file monthly reports as required to the State of New Mexico for the year 1962 and through the Month of April, 1963.

SECOND: That the Defendant failed and refused to pay Three Hundred Sixty-Six and 66/100 Dollars (\$366.66) motor vehicle fuel tax to the State of New Mexico for the year 1962 and through the Month of May, 1963.

THIRD: That the Plaintiff was required to pay to the State of New Mexico the sum of Three Hundred Sixty-Six and 66/100 Dollars (\$366.66) as surety on the bond as aforesaid.

FOURTH: That the Plaintiff has demanded payment from the Defendant of the sume of Three Hundred Sixty-Six and 66/100 Dollars


(\$366.66) for losses incurred by the Plaintiff as a result of the breach of the conditions of the bond by the Defendant as aforesaid.
