COUNT I.

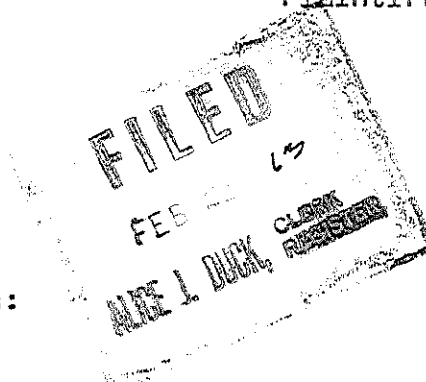

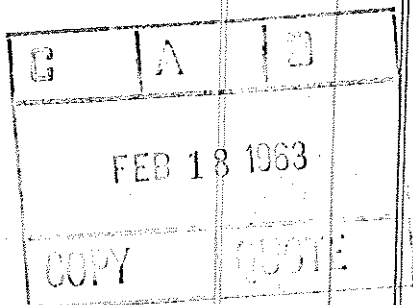


