Said contract provides for a reasonable attorney's fee, which Plaintiff alleges to be NINETY AND 00/100 (\$90.00) DOLLARS.

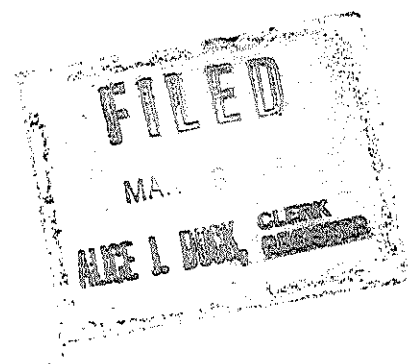
