TO HONORABLE HUBERT M. HALL, AS JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA:

The petition of Delene Steele Allen, who is over the age of 21 years and who is a resident citizen of Mobile County, Alabama, respectfully shows and represents unto your Honor:

FIRST

That on to-wit, December 11, 1956, your petitioner obtained in this Honorable Court a divorce from Louis T. Steele and that your Honor by proper decree awarded to your petitioner the permanent care, custody and control of Rusty Lavene Steele, age now about seven years. Copy of said decree is attached hereto and made a part of this said petition.

SECOND:

That out of consideration for the aged parents of the said Louis T. Steele, who are the paternal grandparents of the said Rusty Lavene Steele, your petitioner allowed the said child to spend considerable time with the said grandparents who are Tucker Steele and wife, Eva Steele, residing in Robertsdale, Alabama.

THIRD:

That your petitioner was without notice denied the right of access to her said child, Rusty Lavene Steele by the said Tucker Steele who then and there informed your said petitioner he was going to take the said child away from her and that the said Tucker Steele and Eva Steele are illegally restraining said child.

Wherefore, your petitioner prays that a writ of habeas corpus be issued, directing to said Taylor Wilkins, as Sheriff of Baldwin County, Alabama, commanding him to bring the body of Rusty Lavene Steele, before your Honor at the time and place to be by you appointed.
