#### COUNT ONE:

That in and by the terms of said instrument, the Plaintiff waived all rights of exemptions under the Constitution and laws of the State of Alabama, and the Plaintiff now claims the benefit of said waiver.

That in and by the terms of the said written instrument, the Defendant promised to pay a reasonable Attorneys fee, if the indebtedness secured be placed in the hands of an Attorney for collection and the Plaintiff claims the further and additional sum of One Hundred Thirty-Five Dollars (\$135.00) as a reasonable Attorney's fee.
