The Complainant further prays that upon final hearing of this cause, your Monor will grant to her a decree of divorce forever barring the bonds of matrimony existing between her and the Respondent: that your Monor will give and grant into her such other, further, different and general releif as she may be in equity and good conscience entitled to receive and as in duty bound she will ever pray.


