

#### COUNT ONE

The plaintiff claims of the defendant the sum of, to-wit, Three Hundred Seventy-Five & No/100 Dollars (\$375.00) balance due by promissory note made by the defendant on, to-wit, the 3rd day of November, 1961, and payable in twenty-four (24) installments beginning on, to-wit, the 15th day of November, 1961.
