COUNT ONE:

The Plaintiff claims of the Defendant the sum of Two Hundred Thirty-seven Dollars (\$237.00) due by Promissory Note made by him on the 8th day of August, 1962, and payable in installments by the 1st day of June, 1963, with interest thereon at the rate of eight percent (8%) per annum from maturity, which sum of money is still unpaid. The Plaintiff avers that in, by and as a part of said note the Defendant agreed to pay all costs of collecting or securing, or attempting to collect or secure this note, including a reasonable attorneys fee, whether the same be collected by suit or otherwise, and the Plaintiff claims of the Defendant the further and additional sum of Fifty Dollars (\$50.00) as such reasonable attorney's fee.

The Plaintiff further avers that in, by and as a part of said note the Defendant waived as to this debt, all rights of exemption under the Constitution and laws of the State of Alabama, and the Plaintiff claims the benefit of such waiver.
