



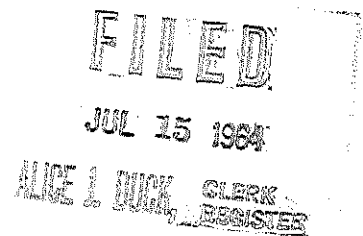
COUNT ONE
