That your Complainant and the Respondent were married at Union Springs, in Bullock County, Alabama, on, to-wit: December 31, 1918, and lived together as husband and wife until August, 1931;

That, to-wit: in August, 1931, the Respondent voluntarily abandoned the bed and board of the Complainant and her husband, ever voluntarily and continues such since that time.

Therefore the premises considered, the Complainant prays that your Honor will by proper process ask the said Respondent, ELLIE PITTS GRI, party respondent to this Bill of Complaint, requiring her to plead, answer, or demur to the same

within the time and under the penalties prescribed by law and the practice of this Honorable Court.

Your Complainant further prays that upon a final hearing of this cause your Honor will hear and enter a decree awarding to him an absolute decree of divorce, forever barring the basis of matrimony existing between him and the respondent; that your Honor will give and grant unto him such other, further, different, and general relief as he may be in equity and good conscience entitled to receive and to his duty bound he will ever pray.
