My name is Emma Wilson. I am over twenty-one years of age and a resident of Baldwin County, Alabama, however, at present I am staying in Mobile, Mobile County, Alabama. The Respondent, Walter R. Wilson, is over twenty-one years of age and a resident of Baldwin County, Alabama.

The Respondent and I were married at Bay Minette, in Baldwin County, Alabama, on either the 30th or 28th day of February, 1940. We lived together as husband and wife, until December 5th, 1940.

The Respondent is a man of high and uncontrollable temper and often times cursed, threatened and abused me and on one occasion did actual violence to me by striking me in the face with his hand. His conduct of the Respondent was such and it grew worse from time to time that I could not live with him as his wife. His conduct was such to cause me every apprehension to believe and - did actually believe that if I continued to live with him, he would carry out his threats and do violence to my person that would necessarily endanger my life and health.

I know that it is absolutely impossible for me to live with him any longer as his wife.

ERNEST L. WILSON, A SWORN AS COMPLAINANT, EMMA WILSON, AS RESPONDENT, DEPOSED AND SAID:

My name is Ernest L. Wilson.

I am personally acquainted with Emma Wilson and Walter R. Wilson, and knew them while they lived together in Baldwin County, Alabama, as husband and wife.

I know of my own personal knowledge and have heard on several occasions the Respondent cursed and abused the Complainant and on one occasion, I know he struck her in the face with his hand or fist. I know the conduct of the Respondent was such that it was impossible for the Complainant to live with him as his wife with any peace.
