TO HONORABLE TELFAIR J. MASHBURN, JR., AS JUDGE OF THE CIRCUIT COURT OF BALDWIN COUNTY, ALABAMA:

The petition of Richard Norl, who is over the age of 21 years and who is a resident citizen of Baldwin County, Alabama, respectfully shows and represents unto your Honor:

FIRST

That he is now illegally restrained of his liberty and is imprisoned in the county jail of Baldwin County, Alabama, at Bay Minette in said County, by Honorable Taylor Wilkins, the Sheriff of said County, the said Honorable Taylor Wilkins, as Sheriff of said County restrains your petitioner under a commitment issued by Honorable Perry McClelland, a Justice of the Peace, after a preliminary trial in which your petitioner was bound over to await the action of the Grand Jury, and your petitioner respectfully shows unto your Honor:

SECOND

That he was ordered held under excessive bail in that the said Justice of the Peace set his bail at \$3500.00 on a charge of Assault with Intent to Murder, without benefit of counsel.

THIRD

That your petitioner is being illegally held in that the said bail being excessive is in violation of Section 16 of the Constitution of 1901 which prohibits excessive bail and that your petitioner is without properties and is unable to raise or obtain bail in the sum of \$3500.00, the cost of a professional bail bond being beyond the financial ability of your petitioner.

Your petitioner prays that a writ of habeas corpus be issued, directed to said Taylor Wilkins, as Sheriff of Baldwin County, Alabama, commanding him to bring the body of your petitioner, Richard Norl, before your Honor at the time and place to be by

you appointed, together with the cause of petitioner's detention.
