
BILL OF COMPLAINT

I

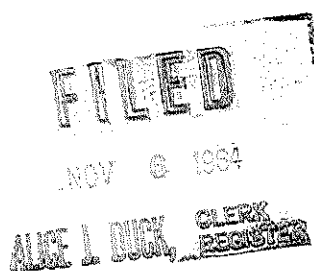
