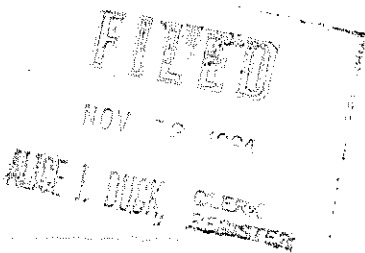

Count I.
