

COUNT ONE

The Plaintiff claims of the Defendants, jointly and severally, the sum of SEVEN HUNDRED SIXTY AND 71/100 (\$760.71) DOLLARS, due from them by promissory note made by them on, to-wit: the 26th day of March, 1963, and payable on, to-wit: the 16th day of January, 1964, with interest thereon.

Plaintiff avers that by the terms of said note Defendants waived all right of exemption under the Constitution and Laws of the State of Alabama and agreed to pay a reasonable Attorney's fee which Plaintiff avers to be the sum of ONE HUNDRED FIFTY-TWO AND 29/100 (\$152.29) DOLLARS. Plaintiff claims the benefit of such waiver and such fee.

WHEREFORE, Plaintiff claims judgment against the Defendants for the total sum of NINE HUNDRED THIRTEEN AND 00/100 (\$913.00) DOLLARS, with the interest thereon.
