statement filed herewith.

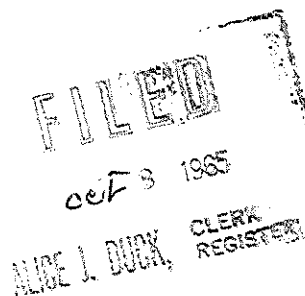
