Defendant between the 4th day of October, 1962, and the 30th day of June, 1964, which sum of money with the interest thereon is still unpaid.

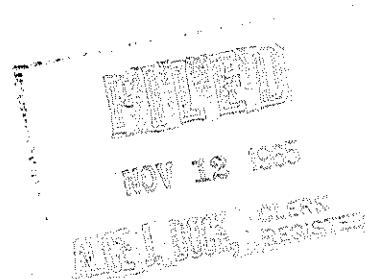


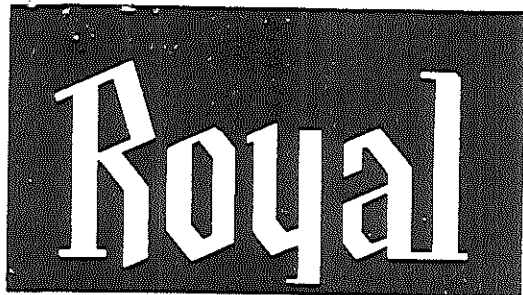
