## COUNT ONE:

The Plaintiff claims of the Defendant, the sum of FOUR HUNDRED SIX AND 08/100 DOLLARS (\$406.08) due from him by account between the Defendant and the Plaintiff on the 28th day of September, 1963, which sum of money, with interest thereon, is still unpaid, and is the property of the Plaintiff.

The Plaintiff claims of the Defendant FOUR HUNDRED SIX AND 08/100 DOLLARS (\$406.08), due from him on account stated between the Defendant and the Plaintiff on the 11th day of January, 1965, which sum of money, with interest thereon is still unpaid, and is the property of the Plaintiff.

## COUNT THREE:

The Plaintiff claims of the Defendant, the sum of ONE HUNDRED TWENTY NINE AND 60/100 DOLLARS (\$129.60) for merchandise, goods and chattels sold by the Plaintiff to the Defendant, under conditional sales contract dated, on to-wit, December 21, 1963, for the total purchase price of ONE HUNDRED EIGHTY AND 35/100 DOLLARS (\$180.35). Plaintiff avers that said merchandise was delivered to the Defendant and that there remains a balance due and unpaid under said contract of the sum of ONE HUNDRED TWENTY NINE AND 60/100 DOLLARS (\$129.60), together with interest thereon at the rate of eight percent (8%) per annum.

Plaintiff alleges that the Defendant agreed in writing, as contained in said conditional sales contract, to waive all rights

and claims to personal property as exempted to him under the laws of this State or any other State, and Plaintiff claims the benefit of said waiver. Plaintiff further alleges that Defendant agreed, in the event that it was necessary for the Plaintiff to hire an attorney to collect this claim, to pay all costs of collection, including a reasonable attorney's fee, and Plaintiff claims the further and additional sum of TWENTY FIVE DOLLARS (\$25.00), as a reasonable attorney's fee in the premises.
