PLEA IN ABATEMENT

Comes Irvin Craft, by and through Walter Cornelius, his Attorney, and appearing specially for the purpose of filing this plea in abatement, and for that purpose alone, moves the Court to quash the service of the summons and complaint herein, and for grounds thereof assigns the following, jointly and severally:

- (1) For that at all times mentioned in the complaint the said Irvin Craft was, and now is, a bona fide resident citizen of Baldwin County, Alabama.
- (2) For that the said cause of action did not occur in Jefferson County, Alabama.
- (3) For that the alleged transaction did not arise in Jefferson County, Alabama.
- (4) For that there is no written agreement between the parties conferring jurisdiction upon the Courts of Jefferson County, Alabama.
- (5) For that the said Irvin Craft has never used or been known by the name of Irwin Craft.
- (6) For that at no time alleged in the complaint did the said Irvin Craft do business in the name of Irwin Craft, or in the name of Craft Company, or in the individual name of Irvin Craft.
- (7) For that the true name of the proper defendant is Craft Company, Inc., a corporation.

- (8) For that the said Craft Company, Inc., an Alabama Corporation, was incorporated in Baldwin County, Alabama, in the year 1954.
- (9) For that since said date of 1954 the said Irvin Craft has not engaged in commercial business in his individual name or in the name of Craft Company.
- (10) For that the said Irvin Craft never has done business as an individual with the Plaintiff, and is in no manner indebted to the Plaintiff.
- (11) For that the Jefferson County Civil Court has no jurisdiction of this cause of action.

Wherefore, defendant says that this suit should be abated, and should not be allowed to proceed.
