

COUNT ONE

Plaintiff claims of the Defendant the sum of FOUR HUNDRED EIGHT AND 60/100 (\$408.60) DOLLARS as damages, for that, heretofore, on, to-wit: the 29th day of August, 1964, Plaintiff's automobile was being operated along and on Highway U. No. 31 at a point thereon fifty feet south of Magnolia Street in Bay Minette, Alabama, where Plaintiff's automobile had a right to be, and which was a public highway in Baldwin County, Alabama at which time and place the Defendant so negligently operated his motor vehicle as to allow it to run into, upon or against the automobile of said Plaintiff, and as a proximate consequence thereof, Plaintiff's automobile was damaged in that the trunk was bent, smashed and torn, that the left rear bumper was bent, smashed and torn and had to be replaced, and the right front fender was bent, smashed and otherwise damaged, that the rear body section was bent, smashed and had to be replaced, that the right front fender was bent, smashed and torn, that the left headlight was bent, smashed and had to be replaced, that the grill was bent and torn and had to be replaced, all as a result of the negligence of the Defendant as aforesaid, hence this suit.
