COUNT I

The Plaintiff claims of the Defendant FIVE HUNDRED FORTY-ONE AND 06/100 (\$541.06) DOLLARS due by promissory note made by him on, to-wit, the 3rd day of April, 1964, and payable in twenty-three monthly installments of TWENTY ONE AND NO/100 (\$21.00) DOLLARS each, beginning May 7, 1964, and the balance of ONE HUNDRED FORTY FIVE AND 80/100 (\$145.80) DOLLARS payable on the 7th day of April, 1966; and the Plaintiff avers that the Defendant defaulted in the payment due on the 7th day of April, 1964, and the Plaintiff under the terms of said note declared the entire unpaid balance due and payable;

And the Plaintiff avers that in said note and as a part of the consideration thereof, the Defendant has expressly waived his rights to claim personal property as exempt to him under the Constitution and laws of the State of Alabama and agreed to pay an attorneys fee for the collection thereof and the Plaintiff hereby claims the further sum of EIGHTY ONE AND 16/100 (\$81.16) DOLLARS as such attorneys fee, (fifteen per cent).
